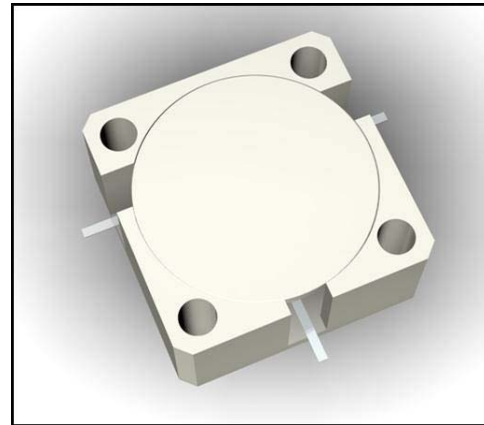

Description

The MAFR-000677-000001 is a single-junction circulator designed for radar. It operates over the frequency range of 2700 MHz to 3100 MHz. Insertion loss is less than 0.35 dB over an operating temperature range of -40°C to $+85^{\circ}\text{C}$.

The MAFR-000677-000001 comes in an industry-recognized package designed for drop-in assembly.

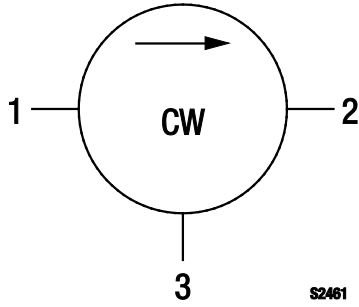


Figure 1. MAFR-000677-000001 Block Diagram

A block diagram of the MAFR-000677-000001 is shown in Figure 1. The absolute maximum ratings of the MAFR-000677-000001 are provided in Table 1.

Electrical specifications are provided in Table 2. Plating information is shown in Table 3.

Figure 2 shows the package dimensions.

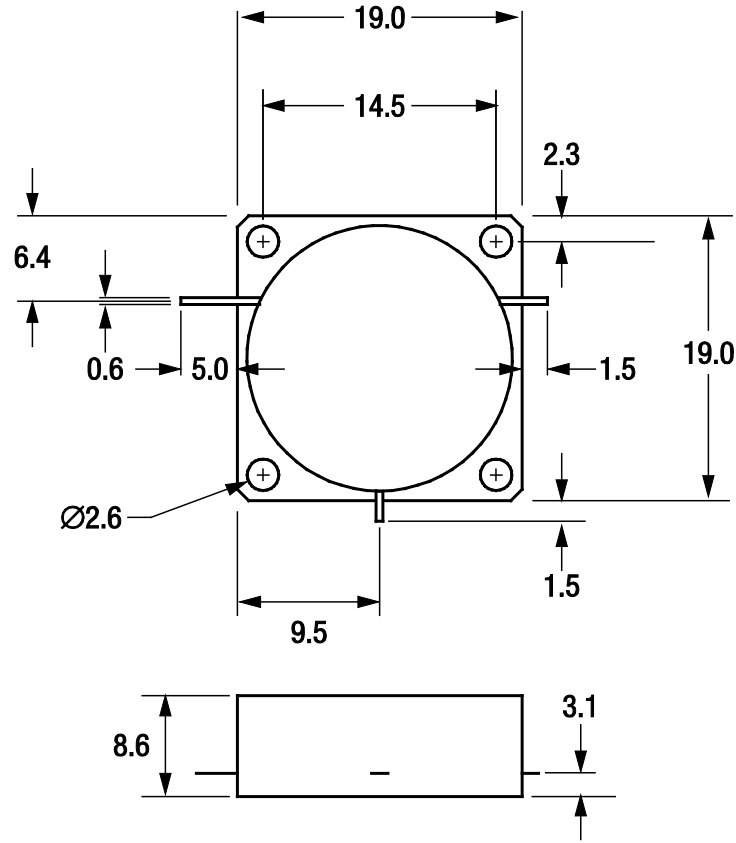
